Our Mission.

The Open Journals Collective (OJC) is an international collective of scholars, libraries, and university-based publishers. We believe that academic research should be available to all, with no author fees and no paywalls. Our mission is to build a sustainable future for academic journals by challenging the profit-making models of global corporate publishing and data systems.

Launching in January 2026, OJC will offer collections of diamond open access journals in the arts, humanities and social sciences (AHSS), and science, technology, engineering and maths (STEM). Published by world leaders in university-based digital publishing, these collections offer libraries and funders the opportunity to support equitable research infrastructure for journals.


By joining OJC, libraries can invest in the long-term sustainability of non-profit university-based journals publishing.

We have designed a scalable pathway to migrate journals away from commercial publishers and subscription models. Titles can "flip" to diamond open access with the OJC, empowering libraries to cancel commercial journal subscriptions or walk



How It Works.

OJC is designed to raise collective investment for a transition to academic-led, non-profit diamond open access. Since our soft launch in March 2025, we have received a high volume of interest from libraries and consortia worldwide looking to become early supporters.



In 2026 (Year 1), we will support diamond open access for c. 300 journals in our two launch collections (AHSS and STEM) and flip 50 journals away from commercial and subscription models in the first 12 months.



01. We offer a viable alternative

to commercial Transformative Agreements, giving back control to academic communities and their libraries.



02. We flip high-quality journals

into our collections, ensuring an equitable and scalable transition to diamond open access.



03. We leverage our academic networks

to move journals away from commercial publishing models and deliver savings for library budgets.

Journal Funding.

Library investment will be distributed to our journals through a series of funding payments that they can receive on an annual basis via a Journal Account on the OJC portal (journals joining OJC with their own publisher can nominate the publisher to receive and allocate this funding on their behalf).

These payments have been calculated following extensive stakeholder interviews with diamond open access publishers. This gives us a clear idea of how much it actually costs to publish a diamond open access journal, when there are no hidden profits or expensive commercial software providers.



OJC Collections.

We are offering 3 Launch Collections of c. 300 diamond open access journals. These include titles that launched as diamond OA journals, titles that migrated to a diamond model with their university-based publisher, and titles that resigned from commercial publishers to flip to diamond OA.

Journal Flipping.

OJC is designed to build its journal collections through an ambitious flipping programme.



Publishing cuttingedge research.

We publish leading academic journals that are openly available - free to read, published with no embargos, and with no author payments. We believe that high-quality research should be available to all.



Giving back to research communities.

We work closely with libraries and funders to support the transition from a profit-driven commercial publishing model to a community-governed publishing model. All funds are invested in our journals and the research communities that make them possible.

Here's how it works:

- OJC advocates find journals looking to move away from their commercial publishers to a diamond open access model.
- **102. Journal editors apply to join OJC** and their applications are evaluated by a Journal Applications Board.
- 03. OJC's Journal Applications
 Committee evaluates applications.
- **16.** If successful, the journal can join OJC and publish independently or partner up with an OJC publisher.
- 05. OJC technical partners support migration and setting up the new journal site.

OJC places control over journals back in the hands of academic editors. We will not "own" the journals that join our collections and can offer support for editors looking to establish their own legal structures to protect journals from commercial acquisition.

The packages are indicative of the revenue distribution of funds raised by the OJC across all journals within its collections. The OJC Funding Committee, which is composed of library members, will decide how funds are allocated each year.

Journal Applications.

From January 2027, journals can apply to join OJC. There are 3 routes to joining:

01.

Journals can apply to join OJC independently as self-published titles, supported by OJC publishing & professionalisation services;

02.

Journals can apply to join OJC with their current publisher / scholarly association;

03.

Journals can apply to join OJC and state in their application that they are looking to partner with a current OJC publisher.

In applications where journals apply to join with their current publisher (No. 2) OJC will evaluate whether their publisher is mission-aligned and conforms to OJC's eligibility criteria.



OJC Publishing & Professionalisation Services.

OJC will draw on the sector-leading skills and services of its members to provide publishing and professionalisation services for new journals joining the collective that need to improve their performance. This includes access to tech support, reduced rates for DOI minting, indexing, archiving, preservation, and discoverability memberships via OJC, support for writing journal and publisher policies, and access to a rapidly growing academic community.

We will provide documentation, training events, and regular community meet-ups for OJC members.



Community Structure.

OJC is leading a growing academic movement.

If we are serious about tackling our broken system of journals publishing, we need to do more than simply move titles away from commercial publishers. We need to redesign the entire architecture of knowledge dissemination and accreditation.

This involves replacing profit-making indicators of prestige, removing our titles from commercially owned databases, which track citation indexing and set the parameters for merit and influence, and building better alternatives.

Our task is ambitious, yet achievable.

Journal Support.

Our core team at OJC will support journals applying to join the collective, accessing professionalisation support, and managing their funding payments. Each journal will be given its own OJC account to receive payments. Payments will be contingent on journals reporting each year to show how they have spent their funds, using accounting software that tracks payments and allows for financial transparency.

Library Hub.

OJC's community structure is designed to begin this important work. Our Library Hub will house usage data for all OJC journals so that libraries can make evaluation-based investment decisions. Librarians will be able to download reports for their institutions drawing on data provided by ROR, the global, community-led registry of open persistent identifiers for research organizations.

Community Hub.


Our Community Hub will bring journal editors into contact with one another.
This will integrate with Knowledge
Commons, the open network for scholarship and academic communities, which is a Founding Member of OJC.

As our Community Hub grows, we can start building alternatives to prestige that are community-governed rather than commercially driven. These include OJC journal awards and rankings.

Community Governance.

Modelled on the Open Book Collective's governance structure, OJC will give its members full control over the running of the organisation. OJC Directors and their staff (the core team) will be accountable to an elected Board of Trustees, as well as a General Assembly of Members. This is designed to empower a community of independent and mutually reliant organisations.

By building a strong collaborative network, we protect bibliodiversity and build resilience against emerging threats (financial, political, and cyber-based).






Library Memberships.

We are launching with 3 collections. Choose your membership level in USD, GBP, and EUR.

- 1. The Multidisciplinary Collection.
- 2. The Arts, Humanities & Social Sciences Collection.
- 3. The Science, Engineering, Technology & Maths Collection.

Each collection is available at a Standard Membership and Higher-Tier Membership rates. Standard Memberships are banded by university size (FTE).



Our fees are banded, based on country and size of institution. Library members are also given the opportunity to voluntarily support us at a higher membership rate, tiered into Bronze, Silver, Gold, and Platinum.

Memberships are available on a three-year or one-year renewable basis. UK members can join via Jisc. Consortial discounts are available.

We use the Jisc banding methodology in the UK. For more information, please visit <u>here</u>.

Institution size is based on the Jisc banding methodology in the UK and the Carnegie Classification of Institutions of Higher Education in the US.
