# Budget & Finance Committee

The Center for Research Libraries Budget & Finance Committee supports the CRL Member Community by reviewing the annual operating plan, including a budgetary total and membership fees, and makes recommendations to the Board of Directors to ensure continued financial and operational activities of CRL and therefore the survival and availability of primary source materials vital to academic research and learning.

First established on April 27, 1990, the Budget and Finance Committee is granted authority via the bylaws (Article VII, Section 3) as amended April 27, 1990. As a standing committee, committee members serve a staggered two-year terms with the chair of the committee serving a one-year term.

### **Committee Charge**

- To review an annual operating plan prepared by the President, including a budgetary total and membership fees, and make recommendations to the Board of Directors.
- To formulate and suggest financial policy to the Board of Directors.
- To review periodically the appropriateness of the membership fee formula and to recommend appropriate revisions to the Board of Directors.
- To review regularly the financial status of the organization. To examine programs for their financial implications and to advise the Board of Directors accordingly.

### **Fast Facts**

- **Committee Composition:** (1) Chair and (4) members appointed by the Chair of the Board and confirmed by a majority vote of the Board members voting; the Chair of the Board and President serve ex officio.
- Minutes: Informal, presented in Committee report of the Board of Directors.
- Staff Liaison: Accounting Manager
- Meeting Frequency: As necessary, but at least once a year.
